Qualifying Fees and Petition Requirements for 2024

The qualifying fee for nonpartisan candidates is 4% of the annual salary of the office the candidate is seeking.

The qualifying fee for partisan candidates is 6% of the annual salary of the office the candidate is seeking.

Qualifying fees must be paid by check from the campaign account. Special district candidates are not required to open an account if not accepting contributions or making expenditures other than qualifying/petition verification fees. See sections 99.061(3); 99.095 (2)(b) F.S. A qualified candidate for a Duval County office must be a registered voter and a resident of Duval County (and the desired district). School Board candidates must be residents of the district for 183 days prior to qualifying.
